



# Creek Side Horse Park

## Rules

- 1) Waiver must be signed for every person entering the park EACH time they come to an event. With or without a horse.
- 2) No unauthorized vehicles permitted on the property. (Example: ATV, Side by side, dirt bikes) If you are handicapped you must have a Creek side permit and follow very specific rules, if rules are not followed permit will be removed. (Contact Creek Side for permit prior to event).
- 3) Horses always have the right away on property.
- 4) Maximum speed at horse park is 10mph.
- 5) No animals allowed inside pavilion or kitchen.
- 6) No permanent connections to the water hydrants. Water is for horse/animal use only.
- 7) This is a private park, any disruptive behavior of any kind is not tolerated and is subject to removal.
- 8) ALL dogs must be kept on a leash or confined while on the horse park property. If a dog is causing issues they will be required to be kept in a trailer or removed from property. If a dog bites some one or another animal they will be removed permanently from the property and the dog warden will be contacted. Aggressive behavior is not tolerated.
- 9) Camping is only at scheduled events and open days with multiple days.
- 10) The racing of horses on the Park property (even trails) is prohibited. Unless it is part of a scheduled event by Creek Side.
- 11) Everyone must stay on marked trails and designated areas. If a trail is not marked it is not a trail and can lead to another property, you could be removed from the park if you are off the marked trails. You are permitted to ride the open fields, on the edge & on the property at your own risk. Make sure you do not venture off the property. Watch for signs. Property does NOT cross any roads.
- 12) All campsites must be kept clean and orderly. When you are finished camping for for the day, you must clean up after yourself and your animals. Leave your site looking better then you found it.
- 13) All trash must be placed in proper areas.
- 14) Camp fires are only permitted if you have a fire ring. Fire rings are not provided.
- 15) All manure should be put in designated areas, not over the hill or in the woods. Manure spreader or bins will be provided.
- 16) All portable corrals must be in designated areas & not past lot lines.
- 17) Portable corrals must use conservative space for the person next to them. All corrals are subject to approval. If unsafe they will have to be removed and go to a tie line if available. They will be inspected once assembled.
- 18) The possession of any illegal substances on the property is strictly forbidden. With that, no one is permitted on the property under the influence of illegal drugs.
- 19) Alcohol is permitted as long as it is kept under control. No drinking and riding on the property at any time. If a person becomes out of control, they will be required to go to their camper and will not be permitted to drink on the property again or removal from the property.
- 20) Helmets are required for 17yrs old and under riders. If a youth is on a horse at any time they must have a helmet on or in hand on the course.

- 21) When course is "Open" to everyone. If there is multiple people/horse on the course. You are limited to 5 min on each obstacle. Keep rotating obstacles. If you are not working on a specific obstacle you must remove yourself/horse from the course. No standing around on the course, people or horses, is permitted.
- 22) No one is permitted on the park property unless there is a scheduled event or open day. Including trails. Any unauthorized visits to the park will disqualify them from any competition and ban from the park with authorities notified.
- 23) Displaying, hunting or discharging of any firearms or fireworks on the park property is strictly prohibited.
- 24) Generators are permitted to run from 6am - midnight. If there is a health issue you must get permission for approval to run all night.
- 25) This facility promotes family, youth and friendly competition. Any issues between participants is subject to removal from the park and subject to disqualification from any awards.
- 26) You are permitted to walk the trails on foot with leashed dogs. Must stay on marked trails.
- 27) There will be no cutting of any trees permitted without approval. If you are in need of firewood, you must ask before you collect or cut anything.
- 28) Camping, Portable Corrals, Trailer parking & non trailer parking have designated areas. No parking in other areas. No unauthorized vehicles are permitted past the main tie lines. Follow signs.
- 29) Open tie lines by the pavilion are for riders coming up to the pavilion or waiting on competing. No leaving horses in this area for extended periods of time.
- 30) All Horses must be tied to the tie line and not to any of the posts.
- 31) Horses can only be tied with halters and lead ropes, no bridles or head stalls.
- 32) For all High point awards, participant must have either OQHA or IMTCA membership to qualify prior to entering in any classes. Prior classes will not count. No membership is needed to compete for the day, not entered in any high point awards.
- 33) For IMTCA Midwest High point, You must declare what level you are competing in prior to entering any classes. You can enter up to 2 levels, only one will count for high point awards. If participant does not declare it will not be counted for those classes.
- 34) All judges scoring is final.
- 35) Parents are responsible for watching their children at all times while at the park and in the play ground.
- 36) Unless you ask permission from horse/dog owner, no one is permitted to do anything with another persons Horse/dog unless it is an emergency situation. (Examples: move, feed, pet, brush) None horse/dog owner, ask owners prior to approaching animals.
- 37) Smoking is not permitted in the pavilion or kitchen. All "Butts" must be put out and in trash cans, do not toss on ground. You will be asked to pick them up if seen. Please help keep our facility clean.
- 38) If you have a Horse that kicks, please identify it with a red ribbon in its tail. Aggressive dogs are identified with a yellow ribbon around neck, if in a class they must be muzzled.
- 39) Any theft, vandalism or threats will have the authorities notified and participant will be permanently ban from the facility.
- 40) Keep off all landscaping.
